- 3. Election of two financial auditors for the upcoming year:
  - 3.1. Andreas Voigt (User Group Germany) -> confirmed with 38 votes in favour and one abstention
  - 3.2. Additional Financial Controller election:
    - 3.2.1. Jeroen Hovens 18 votes (46.2%) -> Elected
    - 3.2.2. Arnaud Morvan 8 votes (20.5%)
    - 3.2.3. Thomas Ramm 7 votes (17.9%)
    - 3.2.4. Abstentions 6 (15.4%)
